REPORT ON STATUS OF CITY FINANCES:

- 1. Romy Stamps provided the Council with a monthly financial report and banking balance update.
- 2. Jason Harpe with Carr, Riggs, and Ingram (CRI) provided an update on the FY 2019 audit. Jason stated that the overall equity in the general fund has decreased over the last several years. The City needs at least 90 days of operation in the general fund. We need to preserve revenue. As of 2019 the audit is showing a -\$5,446,865 fund balance in the general fund. We need to minimize transfers from enterprise fund to general fund to avoid putting the utilities in financial stress. The FY 2019 audit shows \$7.1 million transferred to the general fund.
