The City Council of the City of Alexander City held a work session on Monday, March 20, 2023 at 4:30 p.m. in the Council Chambers at the Municipal Complex, 281 James D. Nabors Drive, Alexander City, AL 35010.

The meeting was called to order by Council President Colvin. Opening prayer was led by Councilor Eric Brown, and Councilor Chris Brown led the Pledge of Allegiance. CALL TO ORDER THE PRE-COUNCIL MEETING: Council President Colvin called the Pre-Council Meeting to order at 5:31 p.m. on Monday, March 20, 2023, in the Council Chambers of the Municipal Complex. Roll was called and all Councilors were recorded as being present.

Council President Colvin asked for information regarding each agenda item.

Amanda Thomas, Community Development Director, explained that Resolution No. 4 is to extend a previous agreement that was entered into November 2, 2021 that will aid in the development of a hotel.

Miles Hamlett, Purchasing Agent, discussed the bid recommendations for Bid no. 23-09 for the purchase of treatment chemicals.

Pastor Steve King, First Baptist Church, expressed his concerns with Resolution No. 6 and believes it to be disrespectful, serving alcohol in such close proximity to the church.

Michelle West, Main Street Director, discussed this year's Gumbo Get Down to be held on April 15, 2023. She invited council members to participate in judging the cook-off.

CALL TO ORDER THE REGULAR COUNCIL MEETING: Council President Colvin called the Council Meeting to order at 5:55 P.M. on Monday, March 20, 2023, in the Council Chambers of the Municipal Complex. Roll was called and all Councilors were recorded as being present.

REPORTS FROM STANDING COMMITTEES:

Council President Colvin: The Revenue Department completed the review of the second set of invoices provided by Russell Lands for the Wicker Point project. A second Sales Tax Rebate check in the amount of \$50,291.12 was submitted to Russell Lands at the end of February. The city has remitted \$107,691.39 back to Russell Lands for the Wicker Point development at this time.

Councilor Eric Brown: No report

Councilor Keel: The Gas Department is installing a gas main on Campground Road. We are also doing our annual gas system survey. If you see someone on your property, they should be in a high visibility vest and in a marked City truck. The Light Dept. has been assisting the IT Department with the Sportplex fiber project and have replaced a few broken poles.

Councilor Chris Brown: We are in the process of hiring a new Nutrition Center Manager. Thanks to Jennifer Carlisle for her service to our senior citizen population over the last few years.

Our senior programs are starting to ramp up at the Sportplex. Stop by and pick up a calendar to see what daily programs we have going on. We are also in the process of planning our spring/summer day trip schedule.

Baseball/Softball Opening Day ceremonies will take place on April 1, 2023 starting at 8:00 a.m. on Field 1.

Lakewinds Golf Course will be hosting a number of tournaments this spring. Lakewinds was also chosen as the host course for the Alabama Recreation and Parks District 5 Golf Tournament to be held on May 17, 2023. More information on this tournament will follow.

We have summer jobs open for both the pool and Lakewinds Golf Course. Check out the Parks and Recreation Facebook site to apply.

Revenues have increased \$20,546.10 over last year. Total for this year thus far is \$202,024.96. Daily average this year is \$1,288.38.

Fuel filters were replaced at the airport on March 13, 2023. We passed the fuel quality inspection from Titan Fuel. We have purchased 8500 gallons of Av Gas and 15,023 gallons of Jet A in 2023.

PAPPIs are out at the airport from the lightning storm on January 3rd. Miles is putting out an RFP to get them replaced.

The gate at the airport is also unusable from the lightning storm. Bill's Electric has been and still is working on getting it repaired.

Council President Pro Tempore Hardy The Street Department completed a culvert replacement on Ridgeway Drive and the road is now back open for through traffic.

The brush trucks are catching up their routes this week after completing all debris removal from the tornado on January 12th. The brush truck drivers and Street Department ramped up their efforts to

finish the debris removal under a deadline of March 18th given to the city which allows us to receive 100% reimbursement from FEMA for the labor and equipment used. We appreciate their hard work on getting this done in that time frame.

Wicker Point Road had the first layer of asphalt go down last week. We are excited to see the progress of this development.

Councilor Tapley Did you know that you can check out a telescope and/or a microscope from Mamie's Place Children's Library? It can be used for up to three (3) weeks.

PUBLIC COMMENTS (3 minutes per speaker):

Ms. Arlene Wyckoff expressed her concern regarding the infrastructure work being done, while her community in North Central suffers from sewer problems and old water pipes. She asked when money would be coming to the North Central community. She further expressed her dissatisfaction with work being done in the area of Highway 63. Mayor Baird explained that the work is being funded with a \$600,000.00 CDBG grant to replace water lines. He further explained that the city has to satisfy the

current grant, and have plans to apply for another grant to address Houston Street, Semmes Street, Parks Avenue, down to North Central to do the same work and extend the new water mains. The city will be requesting bids for the project.

COMMENTS FROM THE MAYOR: There is a need for grass cutters at the Sportplex, Cemetery, and the Green Gateway and encouraged those interested to submit an application. He further acknowledged Drew Meacham and his staff for meeting the March 18th deadline in their clean up following the tornado.

COMMENTS FROM THE FINANCE DIRECTOR: Jason Harpe, with Carr, Riggs & Ingram, will be at the next council meeting to give a report on the final FY20 audit.

COMMENTS FROM THE CITY CLERK: Stephanie Southerland expressed her appreciation to Scotty and Brittany in the Business License department for their work since the January 24th cyber issue. They lost 611 business license transactions and all of the tax transactions from December, 2022. Since they have been able to access the system again on March 1st, they have reprocessed all digital records, processed all of the mail that has been held, processed 2,138 licenses and 721 tax transactions, totaling \$1,976,765.55, logging 42 hours of overtime. They have gotten everything back on track and their hard work is appreciated.

The mayor further thanked Joe Milam, IT Director, and Kyle Parish for their hard work, getting the city's technology restored.

COMMENTS FROM THE COUNCIL:

Councilor Eric Brown thanked everyone for coming and wished everyone a good remainder of the week.

Councilor Chris Brown thanked everyone for attending and encouraged them to enjoy our city parks and golf course.

Councilor Keel expressed his appreciation for those in attendance and those watching live on Facebook. He stated that the council doesn't always agree, but do not have "fallings out".

Councilor Tapley thanked citizens for coming out and expressing their passion. He thanked the mayor, the council, Finance Director and City Clerk for the work they do. Happy Spring!

Council President Pro Tempore Hardy commended Captain McKinney in his professionalism and dedication. He further addressed Ms. Wyckoff in agreement that the community as a whole is included regarding infrastructure projects. He further stated that the Community Development Office is working towards a Comprehensive and Strategic Plan that will aid in these efforts.

Council President Colvin thanked everyone for coming. She reported that last week she was on a Zoom call with Secretary Canfield discussing economic development. She stated that she, along with Romy Stamps, Mayor Baird, and Scott Hardy graduated from the Economic Development Academy held by the Alabama League of Municipalities last year. She expressed the need in working with the Chamber of Commerce, Tallapoosa County Commission, and the EDA and implementing a Comprehensive Plan. The downtown streets mentioned by the mayor are due to be re-bid. She further thanked everyone for the opportunity to serve. There will be disagreements, but they will continue to work together.

Sexual Assault Awareness Month Proclamation April 2023

Sexual Assault Awareness Month (SAAM) calls attention to the fact that sexual violence is widespread and impacts every person in the community. SAAM aims to raise public awareness about sexual violence and educate communities about how to prevent it.

Systems of oppression such as racism, sexism, classism, heterosexism, ageism, ableism, etc. contribute to higher rates of sexual harassment, assault, and abuse. Unfortunately, those same groups are also the most impacted by inequitable systems of oppression in our society, and statistics show:

- More than 1 in 4 non-Hispanic Black women (29%) in the United States were raped in their lifetime (Basile et al., 2022).
- More than 4 in 5 American Indian and Alaska Native women (84.3%) have experienced violence in their lifetime (Rosay, 2016).
- 1 in 3 Hispanic women (34.8%) reported unwanted sexual contact in their lifetime (Basile et al., 2022).
- 32.9% of adults with intellectual disabilities have experienced sexual violence (Tomsa et al., 2021).
- 47% of all transgender people have been sexually assaulted at some point in their lives (James et al., 2016).

As such, we recognize that it will take ending all forms of oppression to end sexual violence worldwide.

Making a connection between various forms of oppression and the underlying causes of sexual assault is crucial to making holistic and lasting change. However, we cannot do this without recognizing historical injustice and realizing how privilege and complacency reinforces oppression.

We can trace a line from sexual violence to systems of oppression - The theme of this year's Sexual Assault

Awareness Month campaign is "Drawing Connections: Prevention Demands Equity." The campaign calls on all individuals, communities, organizations, and institutions to change the systems surrounding us to build equity and respect within the community, workplace, and the future our youth hold.

I join advocates and communities across the country in taking action to prevent sexual violence. April is Sexual Assault Awareness Month, and each day of the year is an opportunity to create change for the

future.



TERMS and CONDITIONS

- 1. Lighting Equipment Lease. This Lease Agreement ("Agreement") states the agreed terms and conditions upon which Alabama Power Company ("APC") will: (i) lease to "Customer" (identified on Page 1) the "Equipment" referenced on Page 1 for use at the stated "Service Address" (the "Premises"); and (ii) provide electric service to operate the Equipment. The "Equipment" includes all poles, bases, wiring, conduit, fixtures, controls, and related items necessary to provide lighting service through the listed fixtures, unless expressly noted otherwise in "Project Notes." Customer acknowledges that regulatory change during the Agreement term may require APC to modify or replace some Equipment.
- 2. Intent and Title. This Agreement is not a sale of the Equipment to Customer. Customer expressly acknowledges that APC retains title to the Equipment and agrees that this Agreement only gives Customer the right to use the Equipment during the Agreement term, so long as Customer complies with all terms and conditions. Customer acknowledges that the Equipment, although attached to real property, always will remain the exclusive personal property of APC and that APC may remove the Equipment when this Agreement ends. Customer authorizes APC, without further consent or action, to file any UCC financing statement or security agreement relating to the Equipment and agrees that APC may record those documents. APC makes no representation or warranty regarding treatment of this transaction by the Internal Revenue Service or the status of this Agreement under any federal or state tax law; Customer enters into this Agreement in sole reliance upon Customer's own advisors.
- 3. <u>Term.</u> The initial Agreement term is stated on Page 1, calculated from the date of the first monthly bill. After the initial term, this Agreement automatically renews on a month-to-month basis until terminated by either party by providing written notice of intent to terminate to the other party at least 30 days before the desired termination date. APC's address for notice is P.O. Box 2641, Birmingham, Alabama 35203; Customer's mailing address is noted on Page 1.
- 4. Payment. APC will invoice Customer per the terms stated on Page 1, subject to any change in the electric service charge dictated by the Alabama Public Service Commission. Customer agrees to pay the amount billed by the due date (20 days after billing date). Applicable taxes included in the Equipment price are subject to change at any time. If a balance is outstanding past the due date, Customer agrees to pay the greater of 1.5% of the unpaid balance or \$2.00 and acknowledges that APC may require Customer to pay a deposit of up to two times the Estimated Monthly Charge in order to continue service. If applicable, Customer must provide a copy of its Alabama sales tax exemption certificate.
- 5. Premises Activity. Customer grants a license and right of access to APC, and its contractors and representatives, to enter the Premises with vehicles and equipment to: (i) install and connect the Equipment and, if applicable, remove or disconnect existing equipment (collectively, the "Installation"); (ii) inspect, maintain, test, replace, repair, or remove the Equipment; (iii) provide electric service for the Equipment; or (iv) conduct any other Agreement-related activity (items—(iv) collectively, the "APC Activity"). Customer will not cause or permit any obstruction that may interfere with APC's access to the Equipment. Customer represents that the individual signing this Agreement on its behalf has authority to do so and that it has express authority from all Premises owners (and any other party with rights in the Premises) to enter into this Agreement and to authorize the APC Activity. Customer is solely responsible for safety of the Premises and agrees that APC has no obligation to ensure the safety of the Premises or persons or property entering onto Customer's Premises.
- 6. <u>Installation</u>. Customer represents that: (i) the Premises' final grade will vary no more than 6 inches from the grade existing at the time of Installation; and (ii) if applicable and required for proper Installation, Premises property lines will be clearly marked before Installation.
 - A. <u>Customer Work</u>. If APC, upon Customer's request, allows Customer to perform any part of the Installation (including trenching) itself or through a third party, Customer warrants that the work will meet APC's installation specifications (which APC will provide to Customer and are incorporated by this reference). Customer is responsible for all reasonable additional costs arising from Customer's non-compliance with APC's specifications or lack of timely (i.e., 10 days') notice to APC that APC's Installation activity can commence.
 - B. <u>Underground Facility/Obstruction Not Subject to Dig Law</u>. Because APC Activity may require excavation not subject to the Alabama's Underground Prevention Legislation (Ala. Code §§ 37-15-1 37-15-11) ("Dig Law"), Customer must mark any private utility or facility (e.g., gas/ water/sewer line; irrigation facility; low voltage data/communication line) or other underground obstruction at the Premises that is not subject to the Dig Law. If APC causes or incurs damage due to Customer's failure to mark a private facility or obstruction before APC commences Installation, Customer is responsible for all damages and any resulting delay.
 - C. <u>Unforeseen Condition</u>. The estimated charges shown on Page 1 include no allowance for any subsurface rock, wetland, underground stream, buried waste, unsuitable soil, underground obstruction, archeological artifact, burial ground, threatened or endangered species, hazardous substance, etc. not properly marked or identified ("Unforeseen Condition"). If APC encounters an Unforeseen Condition, APC, in its sole discretion, may stop all APC Activity until Customer either remedies the condition or agrees to reimburse all APC costs arising from the condition. Customer is responsible for all costs of Equipment modification or change requested by Customer or dictated by an Unforeseen Condition or circumstance outside APC's control.
- 7. Equipment Protection and Damage. After Installation and throughout this Agreement's term, in the event of any work or digging near the Equipment, Customer (or any person or entity working on Customer's behalf) must: (i) provide notices and locate requests by calling Alabama 811 or 1-800-292-8525; and (ii) provide notices to other utilities or operators as required by the Dig Law.. As between Customer and APC, Customer is responsible for all damages arising from failure to comply with applicable law or for Equipment damage caused by anyone other than APC (or an APC contractor or representative).
- 8. <u>Maintenance</u>. During this Agreement's term, APC will maintain the Equipment and will bear the cost of routine repair or replacement. Customer must notify APC of any need for Equipment repair by calling the Business Service Center at 1-888-430-5787.
- 9. <u>Disclaimer; Damages</u>. APC makes no covenant, warranty, or representation of any kind (including warranty of fitness for a particular purpose or of merchantability) regarding the Equipment or any APC Activity. Customer also acknowledges that, due to the unique characteristics of the Premises, Customer's needs, or Equipment choice, the Equipment may not follow IESNA guidelines. Customer waives any right to consequential, special, indirect, treble, exemplary, incidental, punitive, loss of business reputation, or loss of use (including loss of revenue, profits, or capital costs) damages in connection with the Equipment or this Agreement, or arising from damage, hindrance, or delay involving the Equipment or this Agreement, whether or not reasonable, foreseeable, contemplated, or avoidable.
- 10. Indemnity. To the fullest extent allowed by law, Customer agrees to indemnify, release, hold harmless, and, at APC's request, defend APC and its affiliates and contractors (and their officers, directors, employees, representatives, and agents) from or against any loss, damage, cost, expense, or liability (including actual attorneys' fees reasonably incurred and all expenses of investigation and defense) for any damage or claim for personal or bodily injury (including death), property damage (including loss of use), monetary damage, or equitable relief caused by or arising out of any misrepresentation or act or omission of Customer involving this Agreement, the Equipment, or the Premises, whether or not caused by or arising out of the joint, concurrent, or contributory (but not sole) negligence of APC.
- 11. <u>Default</u>. Customer is in default if Customer does not pay the entire amount owed within 45 days of billing. APC's waiver of any past default will not waive any other default. If default occurs, APC, at its discretion, may immediately terminate this Agreement, collect all past due amounts (including late fees) and all amounts due for the Equipment during the remaining Agreement term, remove the Equipment from the Premises, and seek any other available remedy.
- 12. <u>Miscellaneous</u>. This Agreement contains the parties' entire agreement relating to the Equipment and replaces any prior agreement, written or oral. Only a written amendment signed by each party can modify this Agreement, except that either party may update administrative or contact information (e.g., address, phone, website) at any time by written notice to the other party. Customer will not assign, in whole or in part, this Agreement or its Agreement rights or obligations without APC's prior written consent. No assignment, whether with or without consent, relieves Customer of its Agreement obligations. Customer must provide advance notice of a change in control of all, or substantially all, of Customer's ownership or interest in the Premises. In this Agreement, "including" means "including, but not limited to." Alabama law governs this Agreement. If a court rules an Agreement provision unenforceable to any extent, the rest of that provision and all other provisions remain effective.
