# **Regular Council Meeting Minutes**

281 James D. Nabors Drive Council Chambers of Municipal Complex Monday, March 4, 2024 --- Meeting at 5:30 p.m.

**CALL TO ORDER THE PRE-COUNCIL MEETING:** Council President Colvin called the Pre-Council Meeting to order at 5:30 p.m. on Monday, March 4, 2024, in the Council Chambers of the Municipal Complex. Roll was called, and all Councilors were recorded as being present.

Individuals present included: Mayor Baird, Romy Stamps, Finance Director; Piper Barnett, Records Clerk; Kasey Kaschak, Parks and Recreation Director; Drew Meacham, Public Works Director; Police Captain Tuck; Sasha Stewart, Lynn Miller, Wastewater Superintendent; Kristin Joiner, Human Resources Director; Stephanie J. Southerland, City Clerk. Others present included: Pastor Tony Harris, Arlene Wyckoff, Robert Boleware, Casey Lowe and others. The media was represented by The Outlook.

Kasey explained that there have been major renovations at the Cabin at the Sportplex and feels like the newly renovated cabin justifies a higher rental rate. All renovations have been done inhouse to cut costs. There are 2 new stoves, a microwave, new flooring and an outside deck.

Sasha reported that these items are old, no longer in use and have been sitting around the lot for a while and need to be disposed of.

Drew stated that agenda item #3 is an agreement from the city with ALDOT's plan.

Sasha stated that agenda item #4 is to award bid for items that will allow preparation for paving and is being paid from ACRIP funds. She further reported that agenda item #5 will provide for an outside cleaning service to maintain what was previously known as the Guest House, now named Alex – Young Hollow. This is being presented as a venue and currently has two (2) weddings booked in the near future.

Amanda reported that agenda item #6 has been ongoing for 2 years, and due to the previous bids being over budget, more funding has been acquired through ARC and the city would like to move forward.

Council President Colvin stated that agenda items # 7 and #8 are requests to waive application fees for events planned for the city.

**CALL TO ORDER THE REGULAR COUNCIL MEETING:** Council President Colvin called the Council Meeting to order at 5:38 p.m. on Monday, March 4, 2024, in the Council Chambers of the Municipal Complex. All Councilors were recorded as being present.

**Council President Colvin:** The Finance Department has issued 2,371 business licenses totaling over \$2,000,000.00 in revenue. Late renewals are being assessed a penalty, and the penalty will increase after March 15. She expressed her appreciation to the Finance Department for their work.

**Councilor Eric Brown:** The Fire Department has eleven (11) candidates in school, with an anticipated graduation date in May. There are still blue address number signs available. Congratulations to Dewayne Rathel as being named Alexander City Firefighter of the Year and Detective Christopher Graham for being named Alexander City Officer of the Year at the Alexander City Chamber of Commerce annual meeting.

**Councilor Chris Brown** Lake Martin Trailblazers, along with Parks & Recreation staff have planned our inaugural Easter Egg Hunt to be held at the Sportplex Softball fields on Saturday, March 23<sup>rd</sup> at 9:00am. We will have 3 age divisions 0-4, 5-8 & 9-12. All hunts will start at 10am. Inflatables, prize eggs, music, and a good time!

Baseball/softball opening day will be April 6<sup>th</sup> at the Sportplex. We are looking forward to a great season for each league.

The cabin renovation has been completed and will re-open for booking tomorrow at acpr.recdesk.com. Huge shoutout to Bryan and the Parks and Recreation Maintenance crew for completing this project in-house.

The parking lot expansion project is still ongoing.

The ARPA District 5 basketball tournament was a success. The parks department grossed over \$10,000 from gate sales and entry fees. The 8U boys team won their division and will advance to the ARPA State Championship this weekend in Gadsden.

The Parks Department is looking to hire a weekend security guard. Anyone interested should contact the parks department at 256-392-5761. Golf course is over \$44,000.00 ahead in revenue from this time last year.

The parking lot at the pro shop and looks great.

This week, we will start working on the restroom building on the course, including adding a new roof and other major upgrades to that facility.

The apron expansion project at the airport is slated to begin this month; be on the lookout for more details as we get closer to start the project.

**Council President Pro Tempore Hardy** congratulated our own Sasha Stewart on her promotion to the position of City Purchasing Agent. We greatly appreciate her contribution to the city as Public Works Specialist over the last 3 years. Sasha has always shown dedication to her role and pursued additional responsibilities, most notably in the areas of grants, permit administration, and filling management roles whenever needed. one (1) bid for regulators, and two (2) bids for transformers were opened and read in public on March 4, 2024 at 1:00 p.m.; and

WHEREAS, the bids were submitted to the City Council of Alexander City at their March 18, 2024 meeting; and

**WHEREAS**, the Light Department would like to reject the bid for the regulators and the power transformers and advertise again for those bids; and


WHEREAS, Siemens Industry, Inc was the lowest responsible bidder for the circuit breakers at a cost of \$27,143.00 each; and

WHEREAS, S & Electric was the lowest responsible bidder for the circuit switchers at a cost of \$85,258.17 each with an eighty-eight (88) to ninety (90) week delivery estimate; and

WHEREAS, Southern States, LLC was the second-lowest responsible bidder for the circuit switchers at a cost of \$85,650.00 each with a sixty-six (66) to sixty-eight (68) week delivery estimate.

**NOW, THEREFORE, BE IT RESOLVED,** that the City Council of the City of Alexander City hereby awards the bid for the circuit breakers to Siemens Industry, Inc and the circuit switchers to Southern States, LLC.

**BE IT FURTHER RESOLVED** that the bids for the regulators and power transformers are hereby rejected and will be advertised for bid again.

RE: New Dadeville Road Substation Equipment Bid Recommendations

Dear Ms. Stewart:

Find enclosed separate Certified Bid Tabulations for the Substation Equipment (Circuit Breakers, Circuit Switchers, Transformers and Regulators) as bid on March 4, 2024.

We recommend that the 15 KV Circuit Breakers, manufactured by Siemens Industry Inc., be purchased from Siemens, the sole bidder, with a purchase price of \$27,143 each for a total of \$112,442 for four (4) Circuit Breakers, including Spare Parts.

We recommend that the Circuit Switchers, manufactured by Southern States, be purchased from Southern States LLC, with a purchase price of \$86,650 each for a total of \$171,300 for two (2) Circuit Switchers. The lowest bidder was S&C Electric with a bid of \$85,258.17 each (\$391.83 less), however, the S&C delivery time was 22 weeks longer.

We reached out to several other manufacturers who would normally bid on Transformers and Regulators. We were told, in three (3) different cases, that the only reason they did not have a bid to open was mail delays. Therefore, we recommend that the Transformers and Regulators be rebid, with the hope that the additional bids will result in lower pricing and/or improved delivery.

All original bid documents will be returned later this week, for your records.

# \*\*\* ARTS AND ENTERTAINMENT DISTRICT RULES AND RESTRICTIONS

Public possession and consumption of alcoholic beverages shall be allowed within the Arts and Entertainment District subject to the following rules:

- 1. Patrons may exit a licensed premise with open beverages in approved, shatter resistant containers except that where outdoor sidewalk seating contiguous to an on-premise licensee exists patrons may be served in glass containers so long as consumers not leave the proximity of that licensee.
- 2. Approved containers include any plastic, paper or Styrofoam cup identifiable as being purchased within the District.
- 3. Patrons are limited to one carryout beverage at a time.
- 4. No person may enter a licensed premise with an open or closed container acquired elsewhere including, specifically, another licensed premise within the District.
- 5. Open containers of alcoholic beverages purchased from a licensed premise within the District may be carried into a non-licensed business only at the discretion of that business owner.
- 6. Alcoholic beverages purchased outside the boundaries of the District are prohibited within the District:
  - a. Except for consumption at a Special Event.
  - b. Except for consumption in a private residence or banquet facility.
- 7. No person or motorist may possess an open container in a motor vehicle on a public street or adjacent parking lots at any time.
- 8. Open containers of alcoholic beverages may not be removed from or consumed beyond the designated boundaries of the Arts and Entertainment District.
- 9. Nothing shall be construed to allow the sale of alcoholic beverages to minors and Alabama Beverage Control Board regulations regarding sales to minors will be strictly enforced.
