3. Gerard Brewer, City Engineer, presented a power point presentation about the accomplishments of the Alexander City Rehabilitation Improvement Program (ACRIP) portion of the sales tax. The ACRIP portion of Ordinance 2014-19 expires on November 1, 2018. The Council would like to vote to continue or not to continue the with current sales tax in July.
