



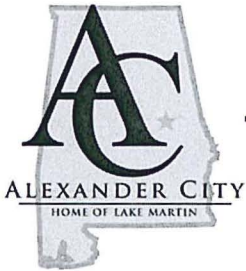


WAIVER OF NOTICE


