- Discuss the Entertainment District: Larkin Radney, Richard Wagoner, Henry Foy, and Jake Mixon concerning the Entertainment District. Mr. Radney stated that the City Council passed Ordinance 2015-11 on March 2, 2015 to allow an Event Committee to schedule and give permits to requesting businesses or organizations.
- Parks and Recreation: Sonny Wilson informed the Council that the City will be responsible for the Alexander City Baseball/ Softball Advisory Board (ACBSAB). The President of the board will be the Assistant Athletic Director, Matthew Keel.
- 3. Presentation concerning Retail Recruitment by Next Site: Chuck Branch with Next Site informed the Council of his role with Next Site and how Next Site could help the City attract desired businesses.
- 4. Discuss 2015 Audit and Proposed 2017/2018 Budgets: Jason Harpe with Carr, Riggs, and Ingram LLC. presented the 2015 Audit to the Council. Mr. Harpe informed the Council that the 2014 and 2015 Audits are similar in the findings / outcome. Mr. Harpe informed the Council that hopefully the 2016 Audit will be ready to present to the Council sometime in the Spring of 2018. The 2015 Audit showed that the City operates on approximately \$61,000.00 per day and that the City has about 43 days of operation in reserves. Mr. Harpe emphasized that the City needs to be able to have a reserve amount to at least operate for 90 days. Mr. Harpe also recommended to allow the enterprise funds to support themselves and allow the general fund to do the same.

Sandy Stanbrough presented the Proposed 2017/2018 Budgets to the Council. The proposed budgets are estimated to be \$55,000,000.00. Attached is the breakdown of the proposed budgets. Stanbrough also stated that there has not been any more information received from the Auburn Study.
