

1 Court Square Council Chambers of Criminal Justice Building Monday, October 2, 2017 --- Meeting at 5:30 p.m.

CALL TO ORDER THE PRE-COUNCIL MEETING: Council President Spraggins called the Pre-Council Meeting to order at 5:30 p.m. on Monday, October 2, 2017, in the Council Chambers of the Criminal Justice Building. During the Pre-Council Meeting Council President Spraggins asked Miles Hamlet, Purchasing Agent, to discuss the resolution to re-award Bid 17-19 for the PPV (Police Pursuit Vehicle) Equipment. Mr. Hamlet stated that Haynes of Montgomery, Alabama, has decided to not uphold the bid submitted on August 8th, 2017. Therefore, the City will need to re-award Bid 17-19 to the next lowest bidder. Mr. Hamlet asked the Council to declare Emergency Lighting by Haynes of Montgomery, Alabama, an irresponsible bidder and re-award Bid 17-19 to Mobile Communication of Columbus, Georgia.

Shelby Richardson spoke to the Council concerning Task Order 9. Mr. Richardson stated that the short-term portion of the task order is to upgrade the pumps at the Dobbs Pumping Station. Phase three is concerning the construction of the HWY 63 Pump Station. The long-term portion is fixing the sewer issues.
