Subject: Wind Creek State Park

Mayor Spraggins,

It was good to talk with you this morning concerning our operations and occupancy at Wind Creek State Park. As we discussed, I do not think Wind Creek is overcrowded. The campground occupancy last night was $23 \%$. The occupancy projections from reservations though the weekend is $21 \%$. We have closed the beach area, the pavilions are closed to group activities and other gather points are closed and monitored. Our Park Rangers are patrolling to make sure social distancing/group size is not violated. We are sterilizing the bathhouses at the campgrounds hourly. We are limiting the numbers of people that can enter the marina store at one time and we have a barrier placed between the cashier and the customers.

We are evaluating all the State Parks, and other DCNR owned/operated outdoor recreation sites around the state on a daily basis to make sound decisions on operations and to ensure the Governor's directives are followed to limit the spread of Covid-19. For instance, we closed two shooting ranges in North Alabama on Sunday because the crowds were too big to maintain safe operations.

We have also coordinated with ALEA Marine Patrol to have an increased enforcement presence on Lake Martin, and other waterways in Alabama this weekend to make sure people maintain the social distancing and no groups over 10 people on the lands along the waterways. With the steps that Russell Lands took this week as well, I anticipate a much more reserved weekend.

Please feel free to give me a call anytime. Thank you for your partnership with Wind Creek State Park. Once we can meet again, I would like to come up to Alexander City and visit with you.
