Unless you receive a notice to the contrary, the following violations may be paid by mail, online, or in-person without appearing in court.

**PAYMENT WILL NOT BE ACCEPTED AFTER 5:00 PM ON THE DAY BEFORE YOUR COURT DATE - YOU MUST EITHER PAY BEFORE YOUR SCHEDULED DATE OR COME TO COURT AT YOUR SCHEDULED DATE & TIME. Failure to pay or appear will result in a warrant being issued for your arrest and your driving privileges may be suspended by the Department of Public Safety.**

Any person charged with **\*IMPROPER EQUIPMENT** may have the equipment repaired and inspected by a Police Officer, signed and dated when inspected and then **return the ticket to the Court Clerk within 72 hours** and the ticket will be dismissed. **DOES NOT APPLY TO TAG VIOLATIONS AND EXCESSIVE WINDOW TINT.**
