

ORDINANCE

To Amend Ordinance Chapter 82, Taxation, Article III Business License Code, Section BL-10 of the Alexander City Code as it Pertains to Business License, Gross Receipts

BE IT ORDAINED by the City Council of the City of Alexander City, Alabama as follows:

Section 1: That Ordinance 2022-26 of the City of Alexander City, Alabama be amended to read as follows:

BL-10 – Less than \$25,000.00 - \$100.00

\$25,000.00 to \$5,000,000.00 - \$100.00 + 1/10 of 1% of Gross Receipts over \$25,000.00

\$5,000,000.00 to \$100,000,000.00 - \$5075.00 + 1/20 of Gross Receipts over \$5,000,000.00

Over \$100,000,000.00 - \$52,575.00 + 1/40 of Gross Receipts over \$100,000,000.00

Section 2: If any paragraph, section, subsection, or provision of this ordinance be declared invalid in a court of competent jurisdiction for any reason, it shall not affect the remainder of the ordinance as it pertains to its validity or to other applications.

Section 3: Any ordinance or provisions of ordinances in conflict with the provisions of this ordinance are hereby repealed and rescinded insofar as they conflict with the provisions of this ordinance, including Section 82-73.

This Ordinance will be published in compliance with Section 11-45-3, Code of Alabama, 1975.

This Ordinance shall become effective immediately upon its adoption.

Section 2: If any paragraph, section, subsection, or provision of this ordinance be declared invalid in a court of competent jurisdiction for any reason, it shall not affect the remainder of the ordinance as it pertains to its validity or to other applications.

Section 3: Any ordinance or provisions of ordinances in conflict with the provisions of this ordinance are hereby repealed and rescinded insofar as they conflict with the provisions of this ordinance, including Section 82-73.

This Ordinance will be published in compliance with Section 11-45-3, Code of Alabama, 1975.

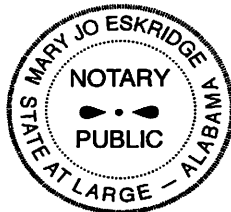
