Add (d) Radio Road from US Highway 280 to Robinson Court


(c) (2) Prohibitions

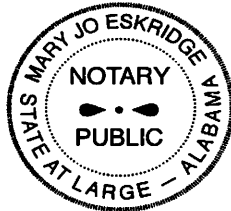
