

RESOLUTION

To Authorize the Mayor to Renew the Contract with the Tallapoosa County Sheriff's Office to House City Inmates

WHEREAS, the City of Alexander City, Alabama (city) has a current contract with the Tallapoosa County Sheriff's Office (county) to house city inmates; and

WHEREAS, the current contract will expire on September 30, 2023; and

WHEREAS, the city and the county have agreed to the following fees for services:

1. The city will compensate the county in the amount of \$50.00 as a booking fee per inmate booked into the county jail.
2. The city will compensate the Tallapoosa County Sheriff \$10.00 per day for feeding each city inmate.
3. The city will compensate the county for health cost(s) of city inmates.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Alexander City, Alabama, hereby authorizes the mayor to enter into said contract, as shown in Attachment A, for the period of October 1, 2023 through September 30, 2024.
