

ORDINANCE

To Amend Alexander City Code Section 62-1, Fees for use of Facilities

BE IT ORDAINED by the City Council of the City of Alexander City, Alabama, as

follows:

SECTION 1. Article I Section 62-1 is amended as follows:

9) Golf cart rentals

- a. Tuesday - Thursday – Regular Rate
 - Eighteen (18) holes \$20.00
 - Nine (9) holes (only) \$15.00
 - Extra Nine (9) holes after eighteen (18) played \$12.00
 - Extra Nine (9) holes after nine (9) played \$10.00
 - Seniors (55+)/Juniors (18 & under) \$18.00
 - Nine (9) holes (only) Senior/Juniors \$13.00
 - Senior/Junior, extra nine (9) holes after eighteen (18) played \$11.00
 - Senior/Junior, extra nine (9) holes after nine (9) played \$9.00
- b. Friday – Sunday – Regular Rate
 - Eighteen (18) holes \$20.00
 - Nine (9) holes (only) \$15.00
 - Extra nine (9) holes after eighteen (18) played \$12.00
 - Extra nine (9) after nine (9) played \$10.00
 - Senior/Junior \$18.00
 - Senior/Junior, nine (9) holes only \$13.00
 - Senior/Junior, extra nine (9) after eighteen (18) holes played \$11.00
 - Senior/Junior, extra nine (9) after nine (9) holes played \$9.00

10) No discounts on golf tournaments. Tournament entry fees at discretion of Golf Course Superintendent.

11) Weekend rates apply to holidays

12) All specials must be approved by the mayor or his/her designee

13) Green fees for one (1) round, or eighteen (18) holes of golf except where noted.

- a. Weekdays, Tuesday – Thursday \$16.00
 - Weekdays, Tuesday – Thursday, eighteen (18) holes \$14.00
 - Tuesday – Thursday, nine (9) holes \$10.00
 - Senior/Junior \$14.00
 - Senior/Junior, nine (9) holes only \$10.00
- b. Weekends, Friday – Sunday \$20.00
 - Nine (9) holes only \$12.00
 - Senior/Junior \$18.00

PRICES ARE SUBJECT TO CHANGE

MONDAY SPECIAL - \$30.00 for everyone, unless it falls on a holiday.

This Ordinance shall become effective upon its passage and publication as required by law.
